**GRADE (E -3) : ASSISTANT MANAGER(LAW)**

1. Qualification : He/she should be a Graduate in any discipline with a Degree in Law. The passing of Odia Language Test equivalent to ME standard is essential. Basic knowledge in computer operation is preferred.
2. Experience : The candidate must have 01 years of bar experience in relevant field.
3. Age : Maximum age 33 years as on 01.04.2018
4. Pay Scale : Rs.15,600-39,100/- with Grade Pay of Rs.5,400/- in E-3 Grade with  
(for Regular or on Deputation Appointment) DA,HRA, Medical Allowances & other perquisites as per rules of the Utility .

**RELAVENT FIELD OF KNOWLEDGE & EXPERIENCE:**

- a) The candidate should have sound knowledge in Indian Penal Code, Criminal Procedure Code, Civil Procedure Code, Evidence Act, Electricity Law, Contract Act, Negotiable Instrument Act, All Labour and Industrial Laws, Protection of Human Rights Act, Right to Information Act, MSME Act, Different Codes framed by the OERC under the Electricity Act,2003 regulating the power distribution and other activities, Consumer Protection Act. In addition, the candidate may have knowledge in other laws and Acts which are applicable to Power Distribution Utilities.
- b) The candidate should have experience in conducting cases before different courts of law and tribunal such as High Court, Lower Courts, Labour Courts, Industrial Tribunal, Consumer Courts, Commissioner Employees Compensation, Odisha Human Rights Commission, Information Commission, Odisha Electricity Regulatory Commission, MSME, BIFR/AIFR, Consumer Disputes Redressal Forum/ Commission etc. He should have experience in preparation of briefs, counters, rejoinders etc to be filed before various Courts, Tribunals & Commissions.



passing of language test in Oriya of M.E standard (not applicable in case of candidates who have passed Matriculation examination with Oriya as one of the language papers) & experience certificate and two self addressed stamped envelope (25cms x 11cms) addressed to **the Asst.
